7. Letters of recommendation from two fully paid-up Regular Members of IPLOCA (not Associate Members) who have been members for at least two years.

8. Your health & safety statistics for the past three years.
9. Confirmation that you will abide by the IPLOCA Health & Safety and the IPLOCA Social & Environmental policies and will submit your health & safety statistics to the IPLOCA Secretariat every year.
10. Confirmation that you agree with and will adopt the IPLOCA Health & Safety Philosophy:
